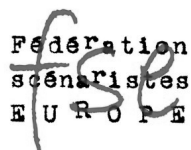

CONFERENCE ON EUROPEAN SCREENWRITING

The conference will be held on Tuesday and Wednesday the **21st and 22nd of November 2006 in Thessaloniki.**
